Big Lift Collaborative


On Tuesday, May 5, the Big Lift Collaborative held a meeting on Zoom to discuss the many adaptations that are necessary because of shelter-in-place directives.

Cabrillo Unified School District has announced that there will be no on-site summer school programs held at CUSD facilities. Hence, no Big Lift summer school classes for pre-K through third grade students will be held. However, support materials are being prepared for families and provisions are being made to ensure that needy children receive food support.

Good news was shared by the Cabrillo Education Foundation that two grants of \$15,000 each were received for pre-school and K through third-grade programs to support innovations required to meet COVID-19 the crisis. This determined group of educators continues to work to provide educational opportunities for the Coastside's early learners so that they can be reading at grade level by third grade. I continue to represent AAUW as part of this collaborative.

AAUW California GovTrek Webinar

If you've been looking for ideas on how to get more women engaged in politics, you will want to join us for a webinar on "GovTrek: How to Rock the Next Generation."

Carlsbad-Oceanside-Vista (COV) Branch recently was awarded a state project grant from AAUW California for GovTrek, an innovative program designed to encourage young high school women to consider a career in politics. This is a six-month course in "how politics really works" and it includes presentations by critical-thinking legislators, and problem-solving activities. and workshops on civil discourse and conflict mediation.

Initially scheduled as a convention workshop, this webinar is your opportunity to learn how your branch might duplicate this project.

The webinar will be presented by **Kathi Harper**, State Director and Co-Chair of the AAUW California Public Policy Committee, and Chair of the COV Public Policy Committee. Topics will include overview of the COV program, how to design a program that works for your community, challenges and ideas for overcoming them, and what worked – and didn't.

Gender Equity in Education Act

Last month, the Department of Education issued a long-anticipated but extremely harmful rule designed to substantially weaken Title IX, rolling back important protections for student survivors of sexual harassment and assault.

AAUW has vigorously opposed this change for more than a year, but this heartless administration chose a global pandemic as the time to finalize it, adding to the confusion and unrest already felt within the education community.

Now we're launching a multipronged campaign in response and we need your help. While we're determined to stop this rule from ever going into effect, we also need to ensure that resources are in the right hands to help students and survivors.

That's why we need you to speak up. We need proactive responses to provide schools with resources to fully realize Title IX's promise of equity in education. Click here to urge your members of Congress to cosponsor the Patsy T. Mink and Louise M. Slaughter Gender Equity in Education Act (GEEA).

GEEA would help reduce and prevent sex discrimination in all areas of education by supporting the vital work of Title IX coordinators through additional resources, training and technical assistance. It would also authorize competitive grants to K-12 schools, colleges, local educational agencies or states to support their gender equity work.

AAUW advocates were key to the passage of Title IX, and we continue to fight today to realize the full promise of the law, despite the recent announcement of this harmful rule.

Urge your members of Congress to build on the legacy of Title IX by cosponsoring GEEA today.

Our Most Successful Coastside Gives!

During these unsettling times, you stepped up to ensure that AAUW Half Moon Bay will be able to continue our mission of empowering women and girls on the Coastside. Not only members, their families and friends, and Tech Trek families, but donors from the community gave generously so that we can continue our programs: local scholarships, Tech Trek, local STEM workshop, Speech Trek and supporting AAUW research and advocacy through the AAUW Fund.

Our 2020 Coastside Gives Fundraiser set records:

- Largest matching fund: \$4,000.
- Most money raised: \$11,126 as of May 21 (by comparison, we raised \$7,493 in 2019).
 - Highest number of donors: 88.

In addition to everyone who donated to Coastside Gives and turned out for our Power Hour, I want to recognize those working behind the scenes. I am grateful for the support of our board, Golden Ticket volunteers, **Peggy Rozhon** for her radio interview, **Betty Lee Kendall** for making sure everyone received the updates, and members who

helped with the last-minute reminders.

Julie Gerth has been part of planning and implementing our Coastside Gives strategy since the beginning. I couldn't do it without her.

The list of thank-yous isn't complete without a heartfelt thank you to the AAUW members who made our \$4,000 matching fund possible: June Baxter, Vivian Costello, Julie Gerth, Jan Grierson, Carol Joyce, Sheila Spieller, Barbara Von Glahn, Allene Zanger and a member who chose to be anonymous.

As the impact of fighting COVID-19 pandemic sank in, I wondered if AAUW's mission would matter to Coastside Gives donors or if they would use their charitable dollars to support nonprofits providing services to those in need on the Coastside. Our success shows that our mission is important to our members and community.

In her Annual State of AAUW speech, CEO **Kim Churches** said that AAUW's mission is as important

as ever and our progress is at risk. An example is found in a May 20 press release with the findings of a new AAUW analysis of student debt. In the press release, AAUW advised: "The global pandemic is making the student country's debt exponentially worse ... AAUW concludes that unless policymakers take further action to combat student debt and bolster the U.S. economy, millions of women college graduates will face unprecedented burdens that will hamper their economic security for years to come." Coronavirus Discovered by a Woman



June Dalziel Almeida (Oct. 5, 1930 – Dec. 1, 2007) was a Scottish virologist who, with little formal education, became a Doctor of Science and a pioneer in virus imaging, identification and diagnosis.

Scientific pioneer **June Almeida** is finally being acknowledged for virology breakthroughs she made a half-century ago. June's work has come roaring back into focus during the present pandemic.

COVID-19 is a new illness, but it is caused by a coronavirus of the type first identified by Dr. Almeida in 1964 at her laboratory in St. Thomas' Hospital in London. Her paper to a peer-reviewed journal was rejected "because the referees said the images she produced were just bad pictures of influenza virus particles."

June Almeida died in 2007 at the

age of 77. Now 13 years after her death she is finally getting the recognition she deserves as a pioneer whose work sped up understanding of the virus that is currently spreading throughout the world.

I was alerted to this woman by Maura Jones, a member of AAUW Half Moon Bay. Thanks, Maura!

Perhaps a woman will discover a cure for COVID-19!

AAUW Statement on Rollback of Title IX Protections

AAUW CEO **Kim Churches** issued the following statement on the U.S. Department of Education final Title IX regulations for schools dealing with sexual misconduct:

Although the nation is facing an unprecedented health emergency that requires singular focus, today the Trump Administration issued a rule that will substantially weaken Title IX, rolling back important protections for student survivors of sexual harassment and assault.

The decision by the U.S. Department of Education to move forward with this change follows more than a year of vigorous opposition from survivor advocacy organizations, civil rights groups and educational institutions. The

outrageous new rule will make it harder for students who have experienced sexual harassment or violence to come forward to get the protections Title IX was created to provide.

Compounding the outrage is the fact that this rule is being finalized amid a global crisis that is causing confusion and unrest, specifically within the education community. To proceed with a policy change will require extensive resources for training implementation while students and schools are already facing unprecedented challenges positively shameful.

In the best of times, the rule is illadvised: It threatens to turn back the clock, reversing policies that were put in place to make it easier for survivors report sexual misconduct. The rules will stack the deck against survivors, making it too onerous, even traumatic, for many to come forward. In short, the antithetical rule is fundamental promise of Title IX, that all students deserve access to an education free from sex discrimination.

But these are among the worst of times. We urge the Administration to keep its focus on protecting our colleges and universities, minding the shaky economy and on keeping Americans healthy and safe. To deprive American students of badly needed protections right now is just plain wrong.

Fair Pay for U.S. Women's Soccer

The U.S. women's national soccer team won the Women's World Cup in 2015 and 2019. By contrast, the U.S. men's national soccer team failed to qualify to play in the 2019 Men's World Cup, yet they continue to be paid more than the women and play fewer games.

The women have been in a legal fight with the Soccer Federation to receive equal pay and facilities. Judge R. Gary Klausner of U.S. District Court for the Central District of California has gutted almost all of the women's claims of unequal pay and treatment.

For example the women, but not the men, often are forced to play on artificial turf, which burns when you slide on it. The Federation installs grass for the men's games, but they claim with the women's game doesn't generate enough revenue to justify the expense.

The Federation lawyers argue that playing for the men's team "carries more responsibility" than playing for the women's team and that "women have less ability."

Tech Trek Camps Canceled Statewide for 2020

In accordance with state mandates and working with campus hosts, AAUW California announced the cancellation of all Tech Trek 2020 camps. Locally, we suspended our selection process when schools were closed in mid-March and before meeting our 12 semifinalists. As soon as Stanford decided in April to close all residential summer camps, the girls received notice that Camp Hopper was canceled.

AAUW California briefly contemplated carrying this cohort of girls over to summer 2021, but after a statewide vote of branch coordinators and camp directors, it was decided to start fresh with the next class of seventh graders next year. Our branch Tech Trek Committee was unanimous in that opinion.

When we can hold public meetings again, we hope to provide a special program or STEM speaker and to invite the 2020 Tech Trek applicants as guests. meantime, the girls will receive a consolation gift, a certificate for being selected by Cunha math and science teachers to apply to Tech Trek, and handmade masks with science motifs sewn by Vivian Costello and Pauline Shue. There is also a possibility of designing our local STEM Camp especially for this cohort next year.

Individual donors to Tech Trek can be reassured that their tax-deductible donations to this 501(c) (3) program have been identified and isolated, and will be expended once we resume camps in the future. AAUW California fully expects to

continue this robust and rewarding program for girls in 2021.

Suffrage and the Cable Act of 1922

When the Nineteenth Amendment was ratified in 1920. some American women still were ineligible to vote. The Expatriation Act of 1907 had stripped women married to foreign citizens of their U.S. citizenship. It effectively Congressional functioned as endorsement of the various ad hoc rulings on loss of U.S. nationality that had been made by the State Department since the passage of the Expatriation Act of 1868.

Therefore, once suffrage was won, these women were not considered American citizens and had no right to vote.

However, Congress swiftly

enacted the Cable Act to restore citizenship to U.S.-born women who had married noncitizen husbands and thereby lost their citizenship under the Expatriation Act of 1907.

This law addressed the discriminatory law that set married women's citizenship according to that of their husbands and enabled white women to retain their U.S. citizenship despite marriages to foreign men. This right did not, however, extend to women who married "aliens ineligible citizenship," especially Asian immigrant men.

The motion to amend our articles of incorporation passed at the 2020 Annual Meeting of AAUW California. The motion corrects a clerical error that occurred when the articles were re-filed in November 2019 and brings the articles into alignment with the tax designation of the corporation with the Internal Revenue Service (IRS) as a 501(c)(4) entity.


Highlighting virtual programming like AAUW's weekly webinar series, including her
